The fine print.....

*Deposit in the form of check/money order is required at the time of booking to hold your reservation. The amount of the deposit will be the Bride's services plus gratuity for her services, and the non-refundable travel fee, if applicable. We will take credit card information but will not charge the card unless you cancel services within 30 days of event. 30-day cancellation notice is required for a full refund. Cancellations within 30 days of event will be charged 75% of the total of all booked services. Final payment due upon completion of services. Final payment is to be made in the form of cash/check or money order (each individual service will need to be paid with cash or check. This means that if you are getting multiple services you will need to bring multiple checks).

*Holiday: Additional fee for appointments booked on holidays or holiday weekends – an additional \$25.00 per service.

*Cancellation Policy: You may cancel your scheduled appointments at any time prior to 60 days before the event. All deposits held will be reimbursed (except non-refundable fees). Cancellations made within 30 days of your scheduled appointments will be charged 75% of the service total. In the event of accident, act of God or other reasons beyond control Perfectly Polished Salon will try to accommodate the openings for availability.

Preparing for you special day:

*Have at least one consultation, and trial style and make-up at least one month before your wedding day.

*During the "test run," walk around with hairstyle you plan to wear to determine its comfort level.

*Bring your head piece and veil to the trial.

*Hair color looks its best in the first two weeks, so have hair colored a week or two before the wedding. Do not have any chemical services the day of the wedding.

*Hair that is over-conditioned does not style well, so deep conditioning treatments should not be used within four days of the wedding. For best styling results, shampoo hair lightly the day before the wedding, and if possible, do not wash hair the day of the wedding. Adding a texture or volumizing mousse before blow drying is recommended.

*Wear a button-down shirt for services the day of appointments.

*For individuals receiving makeup services, face must be clean and moisturized.

*All bridal parties must arrive at the same time as stated on the contractual agreement. Please consider our guests who are scheduled after you. If a wedding party is late for the stylist, the stylist may or may not be able to accommodate the new arrival time. If the scope of the original contract cannot be fulfilled due to client's tardiness, services may be reduced. However, clients are liable for the original total fee and/or forfeiture of deposit.

*Be sure that all members of the bridal party have clean and dry hair. Additional charge of \$10 per person applied if blow drying is required.

By signing or typing your name on this contract, you acknowledge that you have read, understand, and agree to the above terms. Perfectly Polished Salon reserves the right to alter the contract wherever applicable in accordance with changes in accommodations and pricing due to hair thickness, fullness, or intricate style.
